1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

This publication scheme sets out:

- The classes of information that we publish or intend to publish;
- The manner in which the information will be published; and
- Whether the information is available free of charge or on payment.

The scheme covers information already published and information that is to be published in the future. All information in our publication scheme is either available for you on our website or available in paper form.

Some information that we hold will not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Categories of information published

This publication scheme guides you to information that we currently publish (or have recently published) or that we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 5 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

School Prospectus – information published in the school prospectus.

Governors' Documents – information published in governing body documents.

Pupils & Curriculum — information about policies that relate to pupils and the school

curriculum.

School Policies and other information related to the school - information about policies that relate to the school in general.
